



## MUNICIPALITY OF NORTH NORFOLK BY-LAW 4/2015

**BEING A BY-LAW** of the Municipality of North Norfolk to close public reserve, pursuant to Section 139 (1) of *The Planning Act*

**WHEREAS** Section 139 (1) of *The Planning Act* provides as follows:

"Subject to subsection (2), a municipality may close public reserve land by

- (a) Passing a by-law to close the public reserve land;
- (b) Obtaining written approval of the by-law from the minister; and
- (c) Registering the approved by-law and, if required by a district registrar, a plan in the appropriate land titles office".

**AND WHEREAS** the following described public reserve is no longer required for public purposes and it is desirable and expedient and in the public interest that the same be closed;

**AND WHEREAS** the land has been sold to a private individual in the year 2000;

**AND WHEREAS** the public reserve was not closed at the time;

**NOW THEREFORE** the Council of the Municipality of North Norfolk in open session assembled enacts as follows:

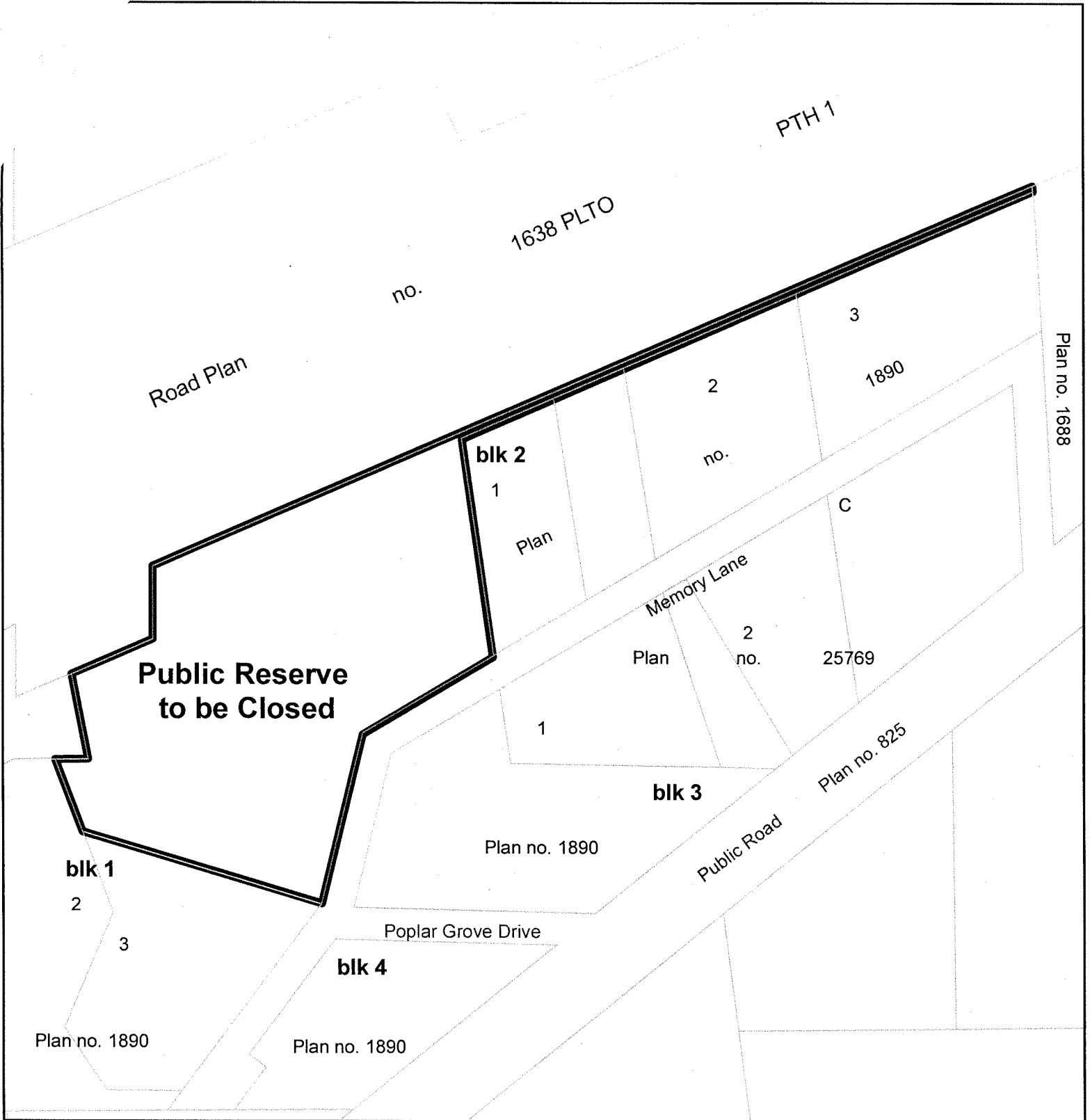
1. THAT all that portion of Public Reserve as shown on Schedule "A" attached hereto as part of Plan 1890 PLTO in the NE ¼ 29-11-11WPM be hereby closed.
2. THAT the Public Reserve so closed shall be retroactive to the date of sale and transferred by the Municipality of North Norfolk to Norfolk Enterprises Ltd.,
3. THAT the proper officers of the municipality are hereby authorized and directed to all acts and execute all documents required for the purpose of implementing the said closing.
4. THAT this by-law shall be valid and in effect on, from and after the day it receives approval of the Minister by written order.
