## **MUNICIPALITY OF NORTH NORFOLK**

## BY-LAW 64/2020 CLOSING OF PUBLIC ROAD

Being a by-law to close a municipal road and authorize the sale of land shown as a road allowance in the Dominion Government Survey.

WHEREAS The Municipal Act provides, in part, as follows:

- 290(1) "Subject to subsection (2), a municipality may close a municipal road by,
  - (a) Passing a by-law closing the road; and
  - (b) [repealed] S.M. 2018, c. 29, s. 26;
  - (c) Registering the approved by-law and a plan at the appropriate land titles office."

291(4) "A municipality may authorize that sale of land shown as a road allowance in the Dominion Government Survey only with the written approval of the member of the Executive Council charged with the administration of *The Crown Lands Act.*"

**AND WHEREAS** the following described municipal road is no longer required for public purposes and it is necessary and desirable and in the public interest that the road be closed:

**NOW THEREFORE** the council of the Municipality of North Norfolk enacts as follows:

1. **THAT** ALL THOSE PORTIONS OF GOVERNMENT ROAD ALLOWANCE AND PUBLIC ROAD PLAN NO 768 PLTO CONTAINED WITHIN THE LIMITS OF A PLAN OF PUBLIC ROAD AND GOVERNMENT ROAD ALLOWANCE TO BE CLOSED PREPARED BY TIMOTHY WILLIAM LONGSTAFF, OF THE RM OF OAKVIEW, MANITOBA LAND SURVEYOR AND ON FILE IN THE WLTO AS DEPOSIT NO. 792/2020

be and the same is hereby closed.

- 2. THAT all that portions of Public Road Plan 768, described as Parcel B in the above noted plan, so closed shall be transferred to Lloyd Walter Bergner excepting all mines and minerals, title to which shall remain in the Crown; and the Chief Administrative Officer is authorized and directed to do all acts and execute all documents required for the transfer.
- 3. **THAT** all that portions of Government Road Allowance, described as Parcel A in the above noted plan, so closed shall remain the property of the Municipality of North Norfolk and be designated as a Conservation Corridor, subject to the by-laws and agreements as set out by the Municipality of North Norfolk and the Whitemud Watershed District.
