



MUNICIPALITY OF NORTH NORFOLK

BY-LAW NO: 52/2019

BEING A BY-LAW OF THE MUNICIPALITY OF NORTH NORFOLK TO ESTABLISH A RATE FOR THE PROVISION OF WASTE AND RECYCLABLE COLLECTION AS A SPECIAL SERVICE WITHIN CERTAIN SPECIAL SERVICE AREAS IN THE MUNICIPALITY FOR 2019 TO 2021, INCLUSIVE.

WHEREAS Section 312 of The Municipal Act of Manitoba, provides in part as follows:

312 If approved by by-law, a municipality may provide, as a special service to all or part of the municipality, one or more of the following:

- e) the collection and transportation of waste or recyclable materials;

AND WHEREAS subsection 320(1) of the Act provides as follows:

320(1) Subject to subsections (2) to (6) and subsection 321(4), a council may by by-law

- a) approve the local improvement or special service as set out in the plan or proposal; and,
- b) authorize the municipality to impose taxes as set out in the plan or proposal.

AND WHEREAS the Council of the Municipality of North Norfolk has prepared Special Service Proposal No. 2019-01 to establish a rate for the provision of waste and recyclable collection within the Municipality of North Norfolk as a special service pursuant to Part 10 of the Act;

AND WHEREAS the requirements as prescribed in section 318, 319 and 320 of the Act have been complied with;

NOW THEREFORE the Council of the Municipality of North Norfolk enacts as follows:

1. **THAT** pursuant to Subsection 320(1) of the Act, the Municipality of North Norfolk approves Special Service Proposal No. 2019-01 attached hereto as Schedule "A".
2. **THAT** the Municipality of North Norfolk levy a Special Service Tax annually upon residential, commercial, institutional, and railway properties, excluding vacant lots, in certain special service areas as hereby attached in Schedule "B".

SCHEDULE "A" TO BY-LAW NO. 52-2019

Special Services Proposal No. 2019 -01

For Provision of Waste and Recyclable Collection

A) Description of the Proposed Special Service

The Municipality of North Norfolk intends to provide waste and recyclable collection service to some of its citizens and to recover the costs of these services via a special service tax.

This Special Services Plan proposes to levy a per parcel tax i.e. an amount for each parcel of land, for provision of waste and recyclable collection service, to all benefiting property owners, including all residential, commercial, institutional and railway property in each of the Special Service areas in the Municipality of North Norfolk excluding vacant lots.

B) Special Service Areas to be Levied

There are five Special Service Areas to be levied under this proposal as follows:

- All Residential, Commercial, Institutional and Railway Property inside the limits of MacGregor, excluding vacant lots as described on Schedule "B" attached hereto.
- All Residential, Commercial, Institutional and Railway Property bordering but outside the limits of MacGregor, excluding vacant lots as described on Schedule "B" attached hereto.
- All Residential, Commercial, Institutional and Railway Property inside the limits of Sidney, excluding vacant lots as described on Schedule "B" attached hereto.
- All Residential, Commercial, Institutional and Railway Property bordering but outside the limits of the LUD of Austin, excluding vacant lots as described on Schedule "B" attached hereto.
- All Residential, Commercial, Institutional and Railway Property inside the limits of the LUD of Austin, excluding vacant lots as described on Schedule "B" attached hereto.

C) Estimated Cost of Service:

The estimated cost of services is based on 2018 costs for the provision of waste and recyclable services.

2018 Levied Costs:	\$ 59,225.00
2018 Actual Incurred:	\$ 66,917.49

The Municipality of North Norfolk will budget the following amount for waste and recyclable collection service included in this proposal:

Any costs for Garbage and Recyclable Collection exceeding the amount raised by Special levies will be funded by the Environmental Health operations budget and will be included in the general municipal levy (At large).

D) Method and Rate of Calculating the Proposed Special Services Tax:

The method to calculate the special service tax will be on a per parcel basis.

The annual amount to be levied on all benefiting properties will be **\$ 95.28.**

The aforementioned Special Services Tax will be set out in the Financial Plan for the year 2019, 2020 and 2021.
