## **ZONING BY-LAW AMENDMENT**



## MUNICIPALITY OF NORTH NORFOLK BY-LAW NO. 38/2017

BEING A BY-LAW of THE MUNICIPALITY OF NORTH NORFOLK to amend THE RURAL MUNICIPALITY OF NORTH NORFOLK ZONING BY-LAW NO. 785-2011, as amended.

WHEREAS it is deemed necessary and expedient to amend THE RURAL MUNICIPALITY OF NORTH NORFOLK ZONING BY-LAW NO. 785-2011;

**NOW THEREFORE**, the Council of the Municipality of North Norfolk, in meeting duly assembled, enacts as follows:

PART 7 – RURAL RESIDENTIAL & SEASONAL RECREATION GENERAL ZONES is amended by changing clause 7.5.1(b) to read "Within a required side yard or required rear yard, no fence or wall shall exceed a height of six (6) feet above the average grade of land within two (2) feet of each side of the fence.", AND;

PART 9 – RESIDENTIAL GENERAL ZONES is amended by changing clause 9.5.1(b) to read "Within a required side yard or required rear yard, no fence or wall shall exceed a height of six (6) feet above the average grade of land within two (2) feet of each side of the fence or wall ....", AND;

PART 10 – COMMERCIAL AND INDUSTRIAL ZONES is amended by changing clause 10.5.1(b) to read "Within a required interior side yard or rear yard, no fence or wall shall exceed a height of six (6) feet above the average grade of land within two (2) feet of each side of the fence.", AND;

PART 11 - OPEN SPACE/RECREATION ZONES is amended by changing clause 11.3.5(f)(ii) to read "six (6) feet within any required interior side yard or required rear yard, AND;

PART 13 - ADMINISTRATION is amended by removing clause 13.6.3(a)(v) and by changing clause 13.6.3(a)(ix) to read "unenclosed portable gazebos", AND;
